CONFERENCE DESCRIPTION

The aim of the conference is to continue discussion between Polish and French researchers, initiated by a publication of a special issue of *Kultura i rozwój* on ethnographic research of public policies targeted at marginalized groups (Sztandar-Sztanderska, forthcoming). In the longer-term perspective, our aim is to lay foundations for Polish-French cooperation in the area of **critical social research of public policies and public action**. The emphasis will be placed on **daily interactive practices of street-level staff with people applying for public services** (e.g. Lipsky, 2010; Brodtkin, 2015) as well as on **their broader implications for social structure and political order**. While there is a number of French studies exploring relationships between policy in practice and social positions of staff of public institutions and those of service users (for an introduction see: Vincent Dubois, 2013; Sztandar-Sztanderska, forthcoming), both subjects have so far received little scholarly attention from Polish researchers, though the interest in them has been recently growing (Niesporek, Trembaczowski, & Warczok, 2013; Sztandar-Sztanderska, 2015, 2016, 2017; Sztandar-Sztanderska & Zielińska, 2018; Sadura, 2017; Rek-Woźniak, 2016; Skowrońska, 2017; Kaźmierczak & Rymsza, 2017; Theiss, 2018; Trochymiak, 2018).

The conference will create opportunity for Polish scholars to meet and to discuss with **French sociologists and political scientists prominent in this research field**, namely **Vincent Dubois** (2019, 2010, 2009, 2017; Dubois, Paris, & Weill, 2018), **Alexis Spire** (2019, 2005, 2008, 2012), **Mathilde Darley** (2013, 2016, 2018) and **Pierre-Edouard Weill** (2017; Barrault & Weill, 2018). The exchanges might relate to results of ongoing research projects as well as to broader conceptual and methodological questions, such as the role of critical research for public policies or the possibility to apply analytical frameworks and to use insights from studies conducted in one (institutional) context to another. Rather than to limit ourselves to one policy area, we would like to open up discussions that go beyond narrowly defined policy sectors and target groups. Therefore, presentations will concern various target groups and policy fields, such as for instance, housing, judicial system, education, immigration, development, welfare and labour market policies.

Conference topics will include:

- street level bureaucracies and street-level organisations (e.g. organisational conditions of administrative work, daily practices of policy accomplishment, application of law, discretionary power of frontline staff, classification practices and people-processing tools, administrative burdens);
- recent changes in public policies that affect encounters of public servants with populations (e.g. new public management, professionalisation and de-professionalisation, information technologies, screen- and system-level bureaucracy, surveillance technologies);
- social and professional backgrounds of frontline staff and service users (e.g. social and professional trajectories, biographical experiences, different styles of policy work, social classes, gender issues);
- broader implications of policy practice for social structure and political order (e.g. differentiated access to services, reproduction of inequalities, discrimination, non-take up, everyday functioning of policies towards marginalized groups);

- conceptual and methodological issues (e.g. advantages and limits of ethnographic methods of analysis, the role of critical research, the applicability of conceptual frameworks and insights from one context of study to another).
